## Housing Quality Standards Owner Self-Certification

Units are eligible for owner self-certification when there are five (5) or less non-health or safety violations, or at HABC's discretion. HABC reserves the right to modify the process of self-certification on a case-by-case basis. Both the property owner/manager and the Head of Household of the subject property must sign this form to certify in writing that the repairs have been completed to meet HQS. Owners that have a record of HQS noncompliance as determined by HABC based on the nature of the noncompliance, will not be eligible for self-certification.

The Property Owner/Manager understands and agrees that failure to correctly make repairs may result in the Property Owner/Manager's exclusion from participation in the self-certification program.

In consideration of the opportunity to participate in the owner self-certification program, the Property Owner/Manager agrees to indemnify and hold harmless, and does hereby indemnify and holds harmless, HABC and its departments and employees, for and against any and all claims, demands,

awards, suits, judgments, liabilities, losses, damages and, sums, including attorney's fees and costs, arising out of or in any way related to this self-certification and/or the Property Owner/Manager's failure to properly repair the deficiencies.

Fraud and False Statements: Title 18, Section 1001 of the U.S. Code states that a person who knowingly and willingly makes false and fraudulent statements to any department or employee of the United States Government, HUD, a Public Housing Authority or a Property Owner may be subject to penalties that include fines and/or imprisonment.
