On Tuesday, September 10th HABC Leadership attended the Perkins Community Meeting and addressed the Perkins Homes residents' concerns regarding relocation benefits and the PSO redevelopment. We emphasized that it is of the utmost importance that all Perkins Homes residents remain in good standing with HABC during the redevelopment of Perkins so that they can return and be a part of the newly developed PSO. Staying in good standing means:

- 1. Keeping current on your rent
- 2. Not receiving lease violations that will cause termination of your lease
- 3. Being responsive to HABC staff and **Diversified Properties when relocation** occurs in your unit

USI CORNER - PERKINS HOMEOWNERS ON THE RISE

Urban Strategies Inc. (USI) & Consumer Credit Counseling of Maryland (CCCSMD) launched its first Homeowners Cohort on September 24th, 2019. Twenty-four Perkins residents attended with the intention of making their CHOICE to improve their credit and the possibilities of homeownership. The families will have the opportunity to engage with a HUD Certified Financial Counselor, a debt manager, a therapist, and a myriad of homeowner programs, financial institutions and more.

The Housing Authority's Office of Residence Services, Above All Odds LLC., the Maryland CASH Campaign and PNC Bank are but a



few of the partners spearheading this project to make the opportunity of homeownership possible for Perkins families. These families are the first of many eager to learn more about and taking advantage of \$7,200 of relocation assistance in the form of closing costs or down payment assistance for anyone eligible for relocation services. In addition to the HABC assistance, individuals may be eligible for up to \$30,000 in additional funding through grants, Live Where You Work credits and more. Over the next eight months, be on the lookout for your fellow residents who maybe closing on their own home. If you are interested in upcoming cohorts, visit 337 S. HABC DEPLOYS EFFORTS TO MAKE 2020 CENSUS A SUCCESS!

Resident Services, Inc. (RSI) has been awarded a grant of \$163,000 to assist with the 2020 Census to provide outreach for hard to count populations. Hard to count Populations include residents of public housing developments.

RSI now has three outreach workers who will be responsible for supporting and assisting residents with computer-aided census counting. Two of the three outreach workers are residents in our developments. Their role is to assist with getting an accurate count, which assures that our communities have access to the additional federal resources they need and, increases the potential for increased representation.

One of the main reasons that an accurate count is so unattainable is because of the concern for reporting to management offices the actual number of people residing in the household. Monitoring activities in the developments, however, is not the role or responsibility of the outreach workers. The outreach workers will also assist in promoting the nationwide campaigns in our developments to assure that people participate in the census including Census Day on April 1st. RSI also has onsite voter registration so that our residents are counted, and their voices heard! The Census enumeration will continue through December, 2020.
