## MESSAGE FROM THE PRESIDENT AND CEO

#### A MESSAGE FROM JANET ABRAHAMS

In HABC's continuing efforts to keep our Perkins Residents informed on the PSO Transformation Plan, we hosted a Resident Update Meeting on Thursday, December 12th. HABC staff, along with its development partners, provided both a project and relocation update. Items discussed included:

 Two PSO project phases (Perkins 1 and Somerset 3) did not receive the competitive 9% tax credits that we were anticipating in the last funding round. Therefore, their financing plans were changed to include non-competitive 4% tax credits with tax-exempt bonds. This will result in the delivery of both projects



being pushed back by several months.

 Henson Development advised that Somerset Phase 1 is under construction and the financing on Somerset Phase 2 would be closing in Summer of 2020 with its construction beginning thereafter.

 Diversified is concentrating on relocating the Phase I residents and early moves will be offered to all residents, regardless of their phase, on a first come, first serve basis.

As always, we appreciate your attendance as it allows us to address your questions and concerns on the spot. We encourage more residents to become involved with the PSO Transformation Plan because your voice matters and we want to hear from you and your family.

#### "HUD CHOICE MEANS CHOICE CONFERENCE 2019-NEW ORLEANS"

Urban Strategies, Inc. (USI) hosted the national HUD Choice Means Choice Conference in New Orleans on November 13-15th, 2019. The Choice Means Choice event was an opportunity to engage in learning workshops for community leaders, choice neighborhood residents and practitioners of Choice Neighborhood Initiative (CNI) Planning and Implementation sites from around the country. The conference consisted of a site tour of two completed CHOICE projects, question and answer session with HUD representatives, nationally renowned keynote speakers, a youth leaders tract, best practice support and opportunities to learn from new and seasoned grantees.

The Housing Authority of Baltimore City and Urban Strategies had the honor of taking two residents from Perkins to New Orleans for the conference. While there, they were able to see an actual site that was fully transformed and speak with original residents from the community who were relocated and then returned back to their home. These families had not only been relocated in New Orleans but across the country due to Hurricane Katrina. Urban Strategies Inc. assisted 90% of the New Orleans families in returning to the site after its redevelopment.

Perkins' Tenant Council Vice President, Denise Street, was one of the individuals who traveled to New Orleans and was able to speak with the families who had returned. Ms. Street described her participation as:

"My experience going to New Orleans was great. I learned a lot going to the workshops. The most exciting thing was the tour to a Choice Neighborhood Site. I got to meet people from other states, and I got to talk to some of the residents who were survivors of Hurricane Katrina. One lady, who was named Ms. Pugh, told me her story and how Urban Strategies got them back home to New Orleans. She said, "Don't be afraid to move temporarily, because Urban Strategies will work to get the residents back. The new homes were beautiful inside and out!"

Many of you may have heard of Magnolia Projects, home of rapper and business mogul, Master P. Below you will see before and after pictures of Magnolia, which are now called the Harmony Oaks Community. This is one of the sites that Ms. Street toured.
