### **DEVELOPMENT UPDATES**

#### **PERKINS**

We are happy to report that Perkins Phase 1 has cleared an important milestone and is projected to close and begin construction in the coming months! Perkins Phase 2 is projected to close in the Fall this year. A huge thanks to everyone who attended the February resident meeting to review and provide feedback on our proposed design for Perkins 5. We have shared our plans and your feedback with the City's design and planning board and are awaiting their approval. Check out the updated designs below of Perkins 5.









# **DEVELOPMENT UPDATES (CONT.)**

#### PERKINS HOMES SITE DEMOLITION

The first phase of Perkins Homes (100 units) has been demolished. The development team is awaiting HUD approval for the next demolition phase of Perkins (114 units). The goal is to have the remaining 415 units demolished by the 1Q 2023.

#### **620 N. CAROLINE STREET**

The 2-story building at 620 N. Caroline Street was built in 1954 by the City of Baltimore to serve as a health clinic providing essential services and programs to neighborhood residents. It served in this capacity until 2019 when the Eastern Health Clinic moved to a new location on Fayette Street. The now-vacant building will be renovated and converted into a laboratory and office space to serve Maryland's growing life science industry. At present, many life science companies that are started in Baltimore by city residents are forced to leave the City when they expand due to the lack of available life science spaces. This adaptive reuse--which will preserve the building's historic features--will help keep entrepreneurs and the jobs they create here in our city.

# **DEVELOPMENT UPDATES (CONT.)**


#### **SOMERSET**

**Somerset Phase 1** (1234 McElderry) is our first completed project and it is over 92% leased. Approximately 20% of the residents are former Perkins Homes residents.

Somerset Phase 2 (The Ella at Somerset) is currently under construction, at approximately 40% towards completion.



Somerset Phase 3 (The Ruby at Somerset) is also currently under construction, at approximately 20% completion.



Somerset Phase 4 (The Blake at Somerset) is projected to close on its financing and begin construction in the 1st quarter of 2023.

When each phase of the PSO Transformation Plan is within six months from construction completion, all previous Perkins Homes residents will receive a notification of the upcoming completion schedule and an offer to return to the project if they have remained lease compliant. This will occur for each of the remaining phases until all nine phases are completed. This is why it is important if your contact information changes you contact us to let us know. # THE NATHANIEL MCFADDEN LEARN AND PLAY PARK (FORMERLY KNOWN AS NORTH CENTRAL PARK)

The North Central Park has been formally renamed the Nathaniel McFadden Learn and Play Park. In honor of its namesake Senator McFadden, who represented district 45 in the Maryland Senate from January 11, 1995 to January 9, 2019 and who was the Senate's president pro tem from January 10, 2007 to January 9, 2019, served as an educator at both Dunbar High School and Lake Clifton-Eastern High School, and received his M.S. from Morgan State College. The Park will feature many educational elements as part of its unique design. The Park's theme will be centered around learning and the Jazz greats that contributed "to helping mold black musical talent - both native and otherwise" in Baltimore. Its design will take into account all ages, physical and learning spectrums. Additionally, the Park will have an Amphitheatre that can be used for community events.


