#### A NOTE FROM YOUR CNI MANAGER, ARLISA W. ANDERSON

Dear Friends,

Happy New Year to you and yours. A lot has happened since our last newsletter. There are three phases of PSO that are under construction, two of which will be completed in Summer of 2023. We have closed on another phase (Perkins 2) and we will be closing on more phases in 2023.

Several PSO team members including Cynthia Newman-Lynch, HABC's Director of Planning & Development, Bridget Hooper, Vice President of Relocation, Denise Street, President of Perkins Homes and myself, attended USI's Choice Means Choice, a Choice Neighborhoods focused conference held in Fort Myers, Florida from November 30th – December 2, 2022. We learned new strategies to enhance our CHOICE Grant in the three pillars (People, Neighborhood and Housing). We also attended the ground breaking of the first phase of Fort Myers CHOICE supported revitalization project located within the greater Dunbar

Community. The Greater Dunbar Initiative is a comprehensive plan to transform the 37-acre, 199-unit Southward Village into a mixed-income community of CHOICE. Much like our own PSO, their plan includes creating new mixed-income housing opportunities, new amenities, a new grocery store, new infrastructure and will increase access to services like education, employment and health care.

All attendees agreed it was great to see and hear about other CHOICE projects throughout the U.S.; meet other CHOICE recipients, housing professionals, resident, and youth leaders; attend housing, neighborhood and people workshops and reflect on how truly far their project has come since receiving its own CHOICE award and initial ground breaking!

# **DEVELOPMENT UPDATES**

#### **PERKINS HOMES UPDATE**

**Perkins 1** – contractors are making great progress on the site. They are preparing the site for the garage ramp, and you can see the rough-ins for the electrical and plumbing conduits.





**Perkins 2** – the financial closing occurred in December 29th and construction has begun with a 18 month construction schedule. The Developer is anticipating closing on the remaining three phases of Perkins in 2023.

#### **SOMERSET HOMES UPDATE**

On November 3, 2022 several staff members from HUD came to Baltimore to attend a HUD Retreat which included a tour of our Somerset Homes and Oldtown sites. Greeted by Janet Abrahams and Dana Henson of Henson Development, we started their tour at 1234 McElderry Street followed by Somerset Phase II & III and Oldtown Mall. # **DEVELOPMENT UPDATES (CONTINUED)**

**The Ella** at Somerset (Somerset Phase 2) is under construction, it's over 80% complete and has a projected completion date of late Summer 2023. There are 192 total units, of which 100 units will be available for our returning residents to choose from to make their forever home. Residents will be receiving a letter in the mail about leasing units once the project is six months from completion, **please be on the look out for your letter for Somerset 2 and Somerset 3.**

**The Ruby** at Somerset (Phase 3) is under construction and is over 66% completed. This Phase has a projected completion date of late Summer 2023. Of the 72 units, 36 units will be available for our returning residents to make their forever home.





**The Blake** at Somerset (Phase 4) is still projected to close by end of 2023 with construction beginning immediately after the financial closing and projected construction completion before September 30, 2025. This project will have 190+/- total units, of which, 66 will be available to our returning resident's and a first-floor grocery store.

## **NEIGHBORHOOD CORNER**

We are excited to see progress continue throughout the PSO footprint and look forward to the changes that will be underway in 2023.

- The Nathaniel J. McFadden Learn and Play Park (formerly North Central Park) will be moving from design to construction in the new year! The Park will feature walking paths, places to sit, talk, think, or just relax, along with play equipment that will appeal to a range of ages and interests. New and returning residents will be able to enjoy performances, movies and more on the new amphitheater's stage.
- Beatty Development, who will be designing and building South Central Park as part of the Perkins redevelopment, was awarded
  a \$250,000 CORE Grant from the State's Department of Housing and Community Development. The new park will be designed
  based on YOUR input, so check back here and the PSO website at https://www.habc.org/habc-information/programs-departments/

- Renovations to the Chick Webb Memorial Recreation Center will begin in the first quarter of 2023. As of December, the Center remains open.
